

# INDEMNITY

In favour of Colin's Horseback Africa, Horseback Africa CC, The (not)parkrun, the Parktrot and any other approved Service Suppliers (hereafter referred to as the Company)

I hereby undertake to abide by the following terms and conditions of operations and indemnity:

1. That I enter vehicles of the Company at my own risk.
2. That I enter the property of the Company at my own risk realising that there are wild animals in the reserve.
3. That I am aware of the dangers involved regarding horses and anything associated with horses.
4. That I am aware of the dangers involved in having close contact with lions and any other wild or domestic animals belonging to the Company.
5. Not feed, nor try to touch, nor touch any animal without authorised permission.
6. Not enter any enclosure without being accompanied by an authorised guide appointed to me.
7. That I shall obey all instructions from both officials and staff of the company and/or any of their service suppliers.
8. That I am aware of the dangers related to flying ultra-lights and any other aircraft belonging to the Company.
9. No pets, animals or firearms of any description are allowed anywhere on the property of Horseback Africa without permission from an authorized person.
10. I understand that I am obliged to notify Horseback Africa of any medical condition which could cause problems during the tours offered by the Company, particularly nervous disorders with regards to the animal interaction tours as well as any medical conditions detrimental to horse-riding or hiking.
11. Horseback Africa reserves the right to deny a guest entrance to the premises and/or taking part in a tour if they feel such person will be placed at unnecessary risk to themselves, the animals, the environment or other people.
12. Each adult must sign this indemnity form and the legal guardian, parent or consenting adult must sign for each child.
13. The copyright to all photographs, both still and moving, remains vested in Horseback Africa and may not be used for any commercial purposes without a written release form signed by Horseback Africa.
14. No children may enter the premises without the authorization and presence of an adult taking full responsibility of such child.
15. I understand that the animal interaction tour is offered for the purpose of enhancing my understanding of wild animals as an educational program.
16. I realise that due to the nature of the animal interaction tour, there may be a chance that I may be scratched or bitten and I cannot claim from Horseback Africa should this happen to me.
17. I declare that I am prepared to act responsibly at all times.
18. I declare that my name and particulars entered onto this form are the truth and acknowledge that should I provide false information that I am liable for prosecution for acting fraudulently.
19. I freely and wilfully agree to all the terms and conditions under which the safaris and activities are being conducted. I hereby agree all information is true and correct and I have read and understood the above.
20. That I hereby waive and abandon any claims against the Company, its directors, servants, employees or agents whilst on the Company's property, and whilst traversing on any land that may be included in the activities of Horseback Africa, or partaking in any activities offered by Horseback Africa, or in their vehicles, whether for personal injury, loss or damage to property from whatsoever cause arising (including negligence) and whosoever caused and I hereby indemnify the Company against any such claim made by any third party.
21. That aforesaid statement shall be legally binding on my heirs, executors, administrators or assigns.
22. That I join the private Equi-social club and agree to compensate the club for liquid refreshments I consume.
